Greyhound ownership is a serious responsibility and commitment. This application is intended to assist Greyhound Pets of America Minnesota (GPA MN) in evaluating the willingness and ability of prospective greyhound adopters to meet that responsibility. You should expect a period of adjustment. Not all greyhounds adjust as quickly as others. For example, some greyhounds may be more difficult to housebreak, while others may be extremely shy at first. GPA MN will assist you in working through these challenges, but you need to be willing to work cooperatively with us to meet the needs of your adopted hound. If you are not willing to put up with temporary problems, you may want to reconsider adopting. Please do not consider adoption if you are not willing to make a lifetime commitment, as a greyhound can live 12 to 14 years. Please also consider the long-term financial responsibility in adopting a greyhound. This responsibility does not end with the adoption fee. While greyhounds tend to be a healthy breed, there are veterinary costs associated with caring for any dog.

Greyhound ownership IS a serious responsibility and commitment, but it is also tremendously worthwhile!
